The City of Rochester is served by Rochester Community Community Choice Aggregation (CCA) Power, program, (municipal authority enabled by NYS regulation) that allows us to pool our community's local electricity provide fixed-rate renewable demand to low cost. electricity supply. Our City has selected Joule Community Power. division Assets. of Joule Inc.. Administrator. Joule works on behalf of our Program municipality to secure clean energy supply at the most favorable terms and ensures there are no contract or exit fees for consumers.

100% Renewable Electricity

The City of Rochester has chosen a 100% renewable default electricity supply. Your electricity supply is matched by Renewable Energy Certificates (RECs) provided by New York State renewable power plants (hydropower, wind, solar). You will automatically be enrolled in the 100% Renewable Option unless you choose to opt-out of the program.

Rochester Community Power Rates

Rochester Community Power has secured rates for electricity through a competitive bidding process that will remain stable and enables you to power your home or business with 100% renewable electricity.

- Constellation NewEnergy, Inc. will be your new supplier, beginning on your first meter-read after September 1, 2022.
- The new rate will remain fixed for a 12-month period through August 2023.

^{*} Rates do not include Gross Receipt Tax (GRT). GRT is authorized by New York State law and applies to utility services provided to all customers in the City of Rochester regardless of energy provider. The added GRT results in a total price of \$0.05979 per kWh for residential and \$0.06059 per kWh for small commercial.

RG&E will continue to be responsible for the power lines that deliver your electricity and will continue to bill you. Please contact RG&E in the event of any service interruption.

Enrollment and your right to opt-out of this program

If you wish to opt-out of the program, please let Rochester Community Power know by August 12th. If they do not hear from you, you will be enrolled automatically in the 100% Renewable Option, and your account information (including energy usage and utility assistance program participant status) will be shared with Constellation NewEnergy, Inc. However, you may leave the program at any time without any fee or penalty. If you choose to remain in the program, your new rate will take effect in September 2022.
